Fellowship Award for International One Year Masters

The National Information Platform for Nutrition (NIPN), FOOD/2017/392-492, funded by the European Union, is a collaboration of Government of Bangladesh and International non-governmental partners led by Helen Keller International and supported by Bangladesh Institute for Development Studies. It is being managed with the support and participation of key governmental institutions: the Bangladesh Bureau of Statistics, the General Economics Division, the Food Planning and Monitoring Unit, the Institute of Public Health and Nutrition, and the Bangladesh National Nutrition Council.

NIPN has been planned as a four-year project, which officially commenced in January 2018. The overall objective of the NIPN is to contribute to the reduction of stunted children in Bangladesh in alignment with WHA 2025 targets. This is being pursued through establishing an inter-agency information and analysis platform for nutrition, strengthening the Government's capacity to monitor progress towards undernutrition reduction, and facilitating implementation of evidence-based policies and programs.

Under its capacity strengthening agenda, there are provisions for a few fellowships for one year international Master program (Fall 2020) in NIPN interest areas such as statistics/biostatistics/data science, epidemiology, public health, demography and public policy (focusing on nutrition & public health) at universities (list enclosed with this circular) in the UK and EU countries. These fellowship will be awarded to the officers of Bangladesh Bureau of Statistics, Statistics and Informatics Division; General Economic Division, Planning Commission; Institute of Public Health and Nutrition and Bangladesh National Nutrition Council, Health Services Division; Ministry of Agriculture; and Food Planning and Monitoring Unit, Ministry of Food.

Conditions and guidelines for application

Fellowship Award for International One year Master Programme

Conditions for application:

All applications will be treated with the strictest confidence.

Applicants must:

- Be a government staff member who is working for a Ministry/department which is collaborating with NIPN.
- Hold minimum a bachelor's degree
- Age should be 40 years or below with confirmed service
- Have to obtain a score of 6.0 in an IELTS examination or equivalent
- Have to obtain an offer letter (fall 2020) from any of the listed universities (attached). Officials having valid offer (fall 2020) letter on specified subjects from a well reputed EU university may also apply
- Agree to work for their respective agencies (and NIPN) for at least three years after their return from studies for strengthening capacity within their respective agencies
- Have a valid passport
- Not presently receiving any other fellowship
- Competent authority shall have the right to revise/relax any of the above mentioned conditions and their decision shall be deemed final in the selection process.

Age should be 40 years or below with confirmed government service (within 10 years of joining the service).

Application guidelines:

Applications for the fellowship are due by 31 March 2020 for courses begin on September 2020. Fellowships will be only awarded for one-year programs that fit within the NIPN funding period.

Seven documents constitute the application:

- 1. The Application form
- 2. A copy of the job description of your most recent official position
- 3. A letter of intent
- 4. A letter of recommendation
- 5. IELTS score sheet (if available at the time of application or have to be obtained before application for enrollment) or equivalent or a certificate for diploma/degree from a foreign English language University with the dates of study detailed. The documentation provided must be at the level or greater than the level required by the selected candidate.
- 6. NID/Passport copy
- 7. Signed copy of Conditions and guidelines for application

Applications Form are outlined in Annex 2. Applications must be submitted in the prescribed format and contain all required documents. Incomplete applications will be disqualified. Paper and hand-written applications are not considered. All applications must be submitted by email before 5.00pm; Bangladesh time on the due date.

The subject line of the email should read: "NIPN Master's Degree Fellowship Application".
